We are committed to reducing greenhouse gas emissions across our operations and supply chain and producing and sourcing resources sustainably to play our part in reducing negative impacts of climate change and biodiversity loss. We strive to minimise our impact on the environment and the communities in which we operate and ensure compliance with environmental legislation as standard.

Our Environmental Policy applies across all C&C Group internal operations, and to management and employees. C&C's ESG strategy of "Delivering to a better world!"<sup>1</sup> guides our collaboration with external stakeholders, including contractors, suppliers, partners, and customers. **C&C Group plc has pledged to be a carbon-neutral business by 2050 at the latest.** We are committed to meeting this target by implementing a range of environmental initiatives across the Group, including but not limited to:

## **REDUCE OUR CARBON EMISSIONS**

- Continuously seeking to optimise our manufacturing facilities and streamline our logistics operations
- Continually pursuing increasing the recycling rate for our brands / improving sustainable packaging
- Maximising, where possible, waste reduction and encouraging circularity
- Piloting alternative fuels and seeking to transition to electric and hydrogen fleet vehicles

## SUSTAINABLY SOURCE OUR PRODUCTS & SERVICES

- Collaborating with our apple & barley growers, and other key suppliers
- Continually seeking to source water optimisation and reduce water usage
- Always seeking to achieve the highest sourcing standards
